- Note: Blanket operating permits are 6 month operating permits that have been bought by the specified operators for unlimited entries into the territory during the time of the permit. All CAACI requirements met plus the operator has purchased the annual blanket permit. These can also be issued in 3 month permits as well.
- Ad hoc verifications are issued to operators that have met the CAACI requirements but they have not purchased a blanket permit and will apply each time that they operate into the territory.
